#### **Abstract**

Due to their common religion, close beliefs and common socio-political experiences, such as colonialism and occupation, the two countries, Iran and Palestine, have been of great importance to domestic and foreign colonialists throughout their political history. Meanwhile, poets, as literary leaders and relying on their social mission, have played a prominent role in fertilizing the revolutionary spirit of the people and dismantling the reins of oppression and injustice. One of the leading figures in the mission in these two countries is Abdul Karim al-Karami and Aref Qazvini, who were able to stand up to the conspiracies of the enemies with their eloquent and striking poems. And keep the spirit of awakening and resurrection alive and protest in the people. In the present study, using descriptive-analytical method and relying on the American School of Comparative Literature, to study some of the topics in the literature of protest, such as; Invitation to unite and fight against internal tyranny, anti-colonialism, protest against patriots and mercenaries and we were able to prove their effective role in Iranian and Palestinian literature in this regard.

- 2. By carefully examining and comparing the socio-political conditions of Iran and Palestine, Abdul Karim Al-Karami and Aref Qazvini can be considered leaders of the intellectual revolution of their time.
- 3. Careful consideration of their poems shows that they have succeeded in accurately portraying society and politics due to their honest feelings, and by creating unique poems, they have taken a special place in the literature of struggle and protest.

#### 3. Methodology

Considering this issue, this research aims to identify and analyze the most important themes of the protest literature of these two nations through their poems, while familiarizing with the intellectual and personal aspects of the two poets, by using a descriptive-analytical method and relying on the American comparative school - unlike the French school that believes that two literary works can be compared without any exchange between the two authors.

## 4. Results

By examining what has been said, we can conclude as follows:

- 1. Abdul Karim Al-Karami and Aref Qazvini are both pioneers of protest literature in Arabic and Persian poetry. Some common protest themes in the poems of these two poets include: protest against colonialists and rulers, the lack of unity of the people, and protest against traitors and mercenaries.
- 2. Both poets have used a simple, uncomplicated language, far from dogma; in such a way that sometimes their poetry has come close to sermons and slogans.

- 3. Sloganism is one of the most important harms and plagues of protest poetry. This sometimes takes away the poetic atmosphere from their poems and reduces them to the level of political statements.
- 4. Both poets love their homeland and motherland with a deep feeling, which is being destroyed under the onslaught of the enemy. The images that both poets present of the homeland indicate the depth of their love for the homeland; A homeland that poets always hope will one day regain its prosperity and freedom.
- 5. The language of Arif's criticism of the kings and rulers of his time is more explicit and serious than that of Abdul Karim, and thus plays a significant role in advancing the socio-political goals of society.
